Meeting began with prayer.

Vice President, Tyler started the meeting with guest speakers and a reminder that each speaker will be allowed 3 minutes to speak without board discussion.

Cassie and Brenda presented a detailed proposal to add a child care program at Unity Ridge. Brochure and outline included.

Megan presented ideas on the benefits of incorporating a Hybrid classroom in the 6-8 grades.

Sara expressed concerns related to the AEA link used in 6-8 classes and shared an event by Inspire Life on April 6th in Manilla. Asked board to share the Mission and Vision for the school

Board discussion on the RDG bill \$10,000. May need to ask if we can set up a payment plan or ask if they would negotiate the cost.

Hybrid Classroom; Merrilee will discuss with Megan.

Board discussed the letter from Ashley Brown related to the 8th grade class trip. Tami will follow up with a call to Ashley, and Carol will follow up with a note.

Discussion on the AEA website, Merrilee talk to the teacher about possibly filtering out some of the questionable content. Will review policies on materials in the classroom.

Board discussed the child care proposal from Cassie and Brenda. The application process for SWVPP is time sensitive and would need to be done soon. Georgia made a motion to have the representatives reach out to the preschool program coordinator or administrator in the district regarding the SWVPP program, and then talk to the Denison school board and ask if they would partner with UR so funds can flow through the public school as required by SWVPP. Cythia seconded. Motion carried.

Cynthia made a motion to give approval to go to the Ar We Va school district if Denison is unwilling, seconded Georgia. Motion carried.
